Green Mountain Civic League Fall General Membership Meeting Minutes October 4, 2015

President: Mr. Phil Riddick, District 5 County Commissioner, was recognized for his dedication and work toward the successful purchase of the Green Mountain property for the greenspace Passive Park, complete with space earmarked for a future Fire Station and helicopter emergency landing capability. Mr. Riddick was presented with a framed picture of the Green Mountain Nature Trail Bridge as a token of appreciation for his efforts.

Captain Dewayne McCarver, the new South Precinct Captain, was introduced and welcomed to partnership with Green Mountain residents.

President: The Fall General Membership Meeting was called to order by the President, Mark Prill. The Spring General Meeting minutes were accepted as previously written. Mark indicated the upcoming Board of Zoning Special Exception meeting regarding the clubhouse would be tabled until later in the meeting given the sensitive nature of the discussion.

Highlights from the Spring Membership Meeting were offered:

Vice President: Beverly Humphrey and Shelly Harris continue to work on getting house numbers on mailboxes. Beverly reiterated that she and Shelly are conducting an audit of South Shawdee and all connecting streets from South and North Shawdee intersections.

Treasurer's report: Anita Reck reported the details of expenses and income from the report. Beginning income January 2015 totaled \$4072.72; income from dues/deductions and decal reimbursements totaled \$1694.00. Expenses of \$808.74 left a balance of \$1059.75. Ending cash balance is \$5132.47.

Membership: Looking for volunteers for GMCL to assist with new memberships. All positions of the GMCL are voluntary, and the GMCL needs more help to sustain the organization.

Database: Volunteers are needed to manage a database of Green Mountain

residents.

Web Page: Michelle Garrett can longer manage the control and/or updates to the Green Mountain web page. Volunteers are needed.

Block Captain: Trying to implement different forms of communication to reach residents, especially in cases of safety of residents. Looking for leadership. GMCL will need buy-in from its members to use telephone number and email addresses. This information will not be shared for any advertising. We currently have 254 email addresses.

Safety: The details of the accident on July 21 were shared; neither driver was seriously injured. The leaning tree across Valley Green has been removed. Road reflectors have been replaced. It was also learned that a stop sign, previously reported obscured from grass/weed growth, was cleared to correct the situation.

<u>Community Watch</u>: Susan Prill has agreed to manage for now until someone volunteers.

Volunteer Fire Department: The Green Mountain Volunteer Fire Department (GMVFD) will be able to keep our current fire engine. The GMVFD has also been successful with the purchase of a Lucas Device, an electrically driven device for performing chest compressions during CPR. The Fire Department has 2 members certified to instruct classes in the use of this device. In need are Personal Protective Equipment (PPE) for the volunteers. A fund raiser will be held later this year to help pay for necessary PPE as well as any necessary upgrades to the current fire engine.

Beautification Committee: Nancy Corbeille and Mike Hollis provided a copy of a diagram, called a conceptual design, of the greenspace park layout. The specific

details of the drawing were discussed. There is a 50x50 signage easement in the NE corner of South Shawdee and South Village Square. There will be a sidewalk if the City determines it is necessary. The City of Huntsville has 2 years from the closing date of the sale for the work on the park to be completed to fulfill the contract obligations. The plan includes a walk through to determine the trees to be saved and/or planted, after which the City will need to approve the conceptual design. Once that is approved, residents can assist in this project, and seedlings can be started if desired.

Nancy reminded Green Mountain residents of the planned Fall Green Mountain Cleanup on October 24.

Old Business:

Nature Trail Picnic Reservation: Mark will talk with Bobby, the Nature Trail Park Manager, regarding a standing reservation for the Green Mountain picnic. **Green Mountain Development**: Mark hosted a general summary and discussion regarding the Inspiration Clubhouse Special Topic GM Community meeting hosted at the GM VFD on the 29th of September, 2015.

New Business:

No additional business was addressed, and the meeting was adjourned.
